

AN ORDINANCE AMENDING CHAPTER 11 –
PARKS AND RECREATION AREAS – OF THE
REVISED ORDINANCES OF THE BOROUGH
OF RINGWOOD TO ESTABLISH FEES FOR
VARIOUS SPORTS PROGRAMS

BE IT ORDAINED by the Municipal Council of the Borough of Ringwood, in the County of Passaic, State of New Jersey, that Chapter 11 – Parks and Recreation Areas – is amended as follows:

1. Section 11-5.2 Organized Program Fees is amended to provide as follows effective January 1, 2010:
